# IT'S ON SURF SCHOOL: TERMS & CONDITIONS

#### **Article 1: ENROLMENT**

All enrolment at It's On Surf School must be made using the registration form, which must be completed in full, by either the parent or the legal guardian for the enrolment of a minor, or by the interested adult. The participant or their parent/legal guardian certifies that he or she has no restrictions in practicing the sport of surfing.

### **Art 2: RESERVATION**

#### **Art 3: COURSE REGULATIONS**

All courses and services reserved with the surf school must be paid in full by the date of the first lesson. It's On Surf School reserves the right to refuse any participant who has not paid in full.

# **Article 4: CANCELATION OF LESSONS**

In the case of poor weather conditions (dangerous surf, pollution, etc...) which render teaching a surf lesson impossible, the participant has the choice of the following options:

- Replace the lesson with another activity
- Change the lesson to another date
- Receive a refund

In the case of cancelation by the participant *after 10:00am the day before the scheduled lesson*, the participant is obligated to pay the full amount of the reservation.

In case of cancelation by the participant made 2 to 5 days before the scheduled lesson, the deposit will not be refunded.

Any cancelation by the participant made *more than 5 days before the scheduled lesson* will receive a full refund.

Lessons not taken by the participant will not be refunded, unless a medical certificate or supporting document is presented in the event of force majeure.

#### **Art 5: RESPONSIBILITY OF THE ENTERPRISE**

Before leaving your child for the surf lesson with It's On Surf School, all parents/guardians must ensure that the scheduled lesson is indeed taking place.

We strongly discourage participants from leaving any valuables in the changing rooms or transport vehicles (money, watch, phone, etc). It's On Surf School declines all responsibility in the event of loss or theft of these items on our premises, at the beach, or in our vehicles.

#### **ART 6: INSURANCE**

Each individual registered with It's On Surf School will be covered by Allianz insurance (Responsabilité Civile, en Individuelle Accident, Assistance et Recours).
